Objective

This project aims to provide practical training to a broad spectrum of legal professionals including national judges and lawyers in the area of the EU Charter. It consists of 8 decentralised seminars spread across the EU designed to bring the essence of the Charter and the common European human rights culture closer to participants. Each seminar will group participants from selected Member States (and, in certain cases, from selected legal professions) in order to allow for an optimal exchange of national experiences and to enhance networking possibilities bearing in mind linguistic barriers and specific legal traditions.

In addition, the series aims to provide an opportunity to further individual and inter-institutional cooperation as well as the exchange of information and the creation of professional networks between European legal professionals in the area of fundamental rights.
