Firstly you will undertake a **short diagnostic test** to make sure both you and we are aware of your language skills based on Common European Framework of Reference to Linguistic Competencies, then you will be offered a variety of relevant compulsory activities in an extent manageable by every busy judge or prosecutor with a wide range of optional activities offering an opportunity to develop and practice your language skills in an environment where learner autonomy is a factor.

The project will include **1 training webinar** session and **one moderate discussion** session at B1 (up to B2 level) with optional training elements on C1 level of EFR for each module and 1 optional training session for C2 level for the module.

There will be **two online sessions** focusing on terminology acquisition and recycling and two will focus on case studies and linguistic comprehension of practical application of the relevant regulation within its language content.

The moderated discussion will focus on opportunities offered to the participant to answer questions and develop ideas directly related to the context of the module while using the linguistic resources acquired through the training sessions.

Step by step guide

1. go to www.edmodo.com website (do not use mobile application for the test, then the edmodo mobile versions can be used)
2. Click on **I am a student**
3. **join the group** - the group code is z5b8j7
4. When registering use a simple user name such as John_Smith_SK (name_surname_ **country of origin**) and **an email address to receive notifications**
5. You can register with the group prior to the test and
6. **On November 21 at 9:00 PM CET, the diagnostic test will be loaded that you will take online and you need to reserve 40 minutes of time to do that** - the time shall start running the moment you push "**start the test**" button
7. **After you have completed the test, you must SUBMIT the test by using the relevant button**
8. We will be notified of the exact date and time the test was submitted to determine the chronological order of the applicants and we will then correct the test and notify you of both your level of English language skills as well as whether you have been selected to participate in the programme.

IMPORTANT NOTICE!

The training is open to **40 participants of V4 countries as well as 24 EU participants.**

If you meet the registration of the entry level language skills and after the "first come first served" principle is applied, you will be notified on registered email of your acceptance in the programme and we shall look forward to work with you.

First 10 participants from Slovak Republic, 10 participants from Czech Republic, 10 participants from Hungary, 10 participants from Poland and one per each of 24 other EU countries will be accepted in this e-learning program based on the time of your test completion **when clicking on the SUBMIT button!**
